Terms and Conditions

- (i) Each participant is only allowed to submit one set of entry. If a participant submits more than one entries, he or she will be disqualified from this competition without further notice.
- (ii) All entries must be original and free from infringement of any existing intellectual property rights. If any participants breach the intellectual property rights, they must fully bear the legal and related responsibilities. Lingnan University reserves the right to pursue legal action.
- (iii) Participants must ensure their entries have not been submitted for any other competition or published in any forms or channels before submitting to this competition.
- (iv) No further revision or re-submission is allowed after submission.
- (v) All entries must be submitted by the deadline [i.e. 11 June 2021, Fri, 17:00 (HK Time); for submission by post, the postmark date should not be later than 11 June 2021]. Late submission will not be accepted.
- (vi) All decisions made by the Judging Panel and Office of the Faculty of Arts of Lingnan University are final.
- (vii) By the act of submitting entries, each participant agrees to assign the copyright of the entries to Lingnan University. Lingnan University will own the copyright of all submissions. Lingnan University can use, duplicate, publish the complete version or part of the submissions perpetually, unlimitedly and unconditionally without additional charges. Lingnan University also owns the reproduction rights of all submissions to Lingnan University.
- (viii) Lingnan University reserves the right to polish and modify the winning logo without the consent of the participant of the winning entry.
- (ix) Lingnan University shall not be obliged to accept any entry as the logo of Lingnan Arts Biennale, should the University consider that none of the entries submitted is appropriate.
- (x) Lingnan University reserves the absolute right to make final decisions in all matters related to the competition, including the interpretation, modification, cancellation or suspension of the terms and conditions, prizes and other arrangements at any time without prior notification.
- (xi) Any violation of the terms and regulations may result in disqualification from the competition, subject to the final discretion of Office of the Faculty of Arts, Lingnan University. There is no appeal mechanism in the competition.
- (xii) In case of any inconsistency between the English and Chinese versions of these terms and conditions, the English version shall prevail.
