Dual Degree Highlights 双学位硕士课程特色:

- UTD Business School ranked top 27 in the U.S. Best Business Schools Ranking (*according to U.S. News Ranking 2024*). 这双学位课程与美国排名第27位的UTD商学院合办。
- To experience and benefit from the unique educational environments offered by both Hong Kong and the United States. 充分让学生体验香港和美国的独特教育环境。
- Complete 14 courses in total, with one semester at LU and two or three semesters at UTD, depends on students' own preferences. 学生共需要完成14门课程，其中在岭大修读一个学期，以及自行选择在UTD修读两个或三个学期。
- Small class size for the first cohort; Students can gain ample support from both universities, and have the opportunity to attend classes alongside U.S. and other international students at UTD. 本课程第一届主打精品班，两校老师会适时提供全面支援；学生可以与当地美国学生及其他国际生一起共同学习。
- Able to adapt to an English learning environment in advance at LU, and be better prepared for studying in the U.S. 学生能够在香港提前适应英语授课环境，有助更充分地准备赴美学习。
- The Programme does not have a white list of accepted schools, and welcome graduates from all accredited undergraduate institutions to apply. 课程不设录取学校的白名单，欢迎所有认可本科院校的毕业生报读。
- High flexibility, students are able to pursue two master degrees in either 1 or 1.5 years, based on their own preference. 课程灵活性高，学生可自行选择在1年或1.5年内完成双边硕士学位。
- Additional options available for students after graduation: A two-years IANG Visa in HK and a three-years STEM OPT in the U.S. (Student must spend two long semesters in the U.S.). 在本课程毕业后可分别获取香港和美国两地工作签证。
- Offer alternative choice for students who are unable to travel to the U.S. and obtain a UTD Degree at last can have a choice to complete the MScFIN Programme at LU. 无法成功赴美且取得UTD Degree的学生可以转读岭大的金融学硕士课程。

Admissions Requirements 入学条件:

- Hold a relevant bachelor's degree awarded by a recognized tertiary institution 申请者需持有认可大学的学士学位。
- TOEFL iBT score 80/ IELTS overall score of 6.5 or above 托福考试最低成绩达 80分 (网考); 或雅思考试最低成绩达 6.5 分。
- An admission interview conducted by LU may be required.符合基本要求的申请人, 有机会需要参加岭大的面试。
- Applicants with no background in accounting, finance, and statistics in their first degree (or equivalent academic qualification) will have to complete and pass a pre-entry course. 申请人如本科 (或具有等同学术资格) 没有修读会计、金融及统计学背景, 将需要完成并通过一门预科课程。
