Honorary Fellow – Citation Mr Andrew FUNG Hau-Chung

Mr Andrew Fung has had a long and distinguished professional career, beginning with his graduation from the University of Hong Kong in 1981. His career path has been impressive, including posts such as Treasurer and Head of Capital Markets Asia for the Commonwealth Bank of Australia; Managing Director, Advisory Sales, Greater China for DBS Bank; and a number of high-level positions with Hang Seng Bank since 2006, culminating in his current post of General Manager and Head of Treasury & Investment. Mr Fung also became a Fellow of the Hong Kong Securities Institute in 2009.

Recognition of his professional achievements has resulted in many opportunities for Mr Fung to serve the government, the financial profession, the universities, and public service organizations. The result is an impressive list of service that can only be briefly summarized here. Mr Fung is currently serving as a member of the Process Review Panel, Products Advisory Committee, and Leveraged Foreign Exchange Arbitration Panel for the Hong Kong Securities and Futures Commission. He has also been appointed to the Federation of Hong Kong Industries, the Business Facilitation Advisory Committee, and is currently a Director of the Hong Kong Mortgage Corporation Ltd. He served as a part-time member of the Central Policy Unit of the HKSAR Government for three years, in 2005, 2008 and 2009. He also served on the Commission on Strategic Development Committee on Economic Development and Economic Cooperation with the Mainland from 2005-2007.

Mr Fung has been serving a number of distinguished professional associations in various capacities, including the Hong Kong Securities Institute, the Institute of Financial Planners of Hong Kong, the Hong Kong Trade Development Council Financial Services Advisory Committee, and the Treasury Market Association. He has also served as President of the Hong Kong Financial Markets Association.

Mr Fung also has an impressive record of service in the higher education sector. He has been an advisor to a number of academic departments and programmes, including the Department of

Finance of Hong Kong University of Science and Technology, as well as the Department of Management Sciences and Master of Arts in Quantitative Analysis programme of the City University of Hong Kong. Both Lingnan University and the University of Hong Kong have benefited from Mr Fung's professional expertise as a member of their investment subcommittees. Meanwhile, he served as a Council Member of Lingnan University from 2003-2009. The University is most grateful for his dedicated service to the Council during these years.

Mr Fung currently serves as Chairman of The Community Chest Dress Special Day Organizing Committee. Opportunities such as this are especially gratifying, as they allow one to give back to the local community in meaningful ways.

As a financial market participant, Mr Fung recognizes the importance of educating and rebuilding investors' confidence, particularly that of small investors, after the minibond crisis and the 2008 financial tsunami.

Mr Chairman, in recognition of Mr Fung's extensive contributions to Lingnan and to the broader community through his outstanding record of public service, may I now present Mr Andrew Fung Hau-chung to you for the conferment of an honorary fellowship.

馮先生現任公益服飾日籌劃委員會主席,藉此機會回饋社會,別具意義。
